2. BACKGROUND

The Professional Examination Board (PEB) is the largest Entrance, Recruitment, and Selection agency body of the State Government of Madhya Pradesh. It conducts approximately 30 Entrance, Recruitment, and Selection examinations in a year. On average, approximately 20 Lakh applicants take part in the examinations conducted by PEB annually.

3. OVERALL OBJECTIVES & POTENTIAL SCOPE OF WORK

Overall Objectives

Professional Examination Board (PEB) intends to explore available potential solutions for the Pre-Exam, During the exam, and Post exam activities. The overall objective of this presentation is to explore the opportunities of establishing a robust, efficient, and transparent Examination Management system

Potential Scope of Work

- 3.1 Development of robust online exam engine with multi-lingual support (Hindi is a must) & API for integration with end-to-end examination process system. Robust security features to handle cheating, impersonation, etc. Provision for complete audit log and retrieval mechanism for online exam.
- 3.2 On the spot result processing (result is shown immediately after the test).
- 3.3 Explore the use of latest tools & technology like facial recognition systems, artificial intelligence, machine & deep learning, video analytics, IoT devices, Business intelligence, BlockChain, etc. in "Question paper authoring", "Online Exam Engine", "Online Proctoring", "Exam Analytics", etc.
- 3.4 Research and Development and adoption of latest academic and technological solutions to improve the exam engine and processes.
- 3.5 Accreditation of Exam Centres
- 3.6 Furnish MOUs with Exam Centre service providers having a total capacity of 35,000 seats and an available minimum of 25,000 seats per shift examination
- 3.7 Supply, install, configure and commission the co-located servers in State Data Centre Bhopal and install system software for application deployment.
- 3.8 Mock Test facility for the registered candidates, so that they can understand Computer Based Exam pattern, exam screen interfaces, typing test interface, etc.
- 3.9 Help Desk for PEB, which shall provide telephonic support to the candidates and citizens for PEB Computer-Based Exam System
- 3.10 Exam monitoring and reporting System
- 3.11 SLA management tool should be able to monitor all the service levels defined in the service level agreement and automatically document problems & interruptions for services and provide the consolidated violations as per the SLA.
- 3.12 Providing exam day manpower, Invigilators, security personnel, and other supporting staff to control candidate mob, validate candidate identity, eligibility credentials
- 3.13 Video Surveillance (CCTV) at all examination centers

- 3.14 Live biometric AADHAR (Fingerprint, Facial recognition webcam, Iris procedure) entry and exit authentication and Identification of Candidates.
- 3.15 Logistics and Supply Chain Management for OMR based offline examination
- 3.16 Covid related sanitization & social distancing protocols.

4. PAYMENT TERMS

Based on the historical trend of attendance in the exams the payment will be 80% of test admit card generated, or actual attendance, whichever is higher, GST will be extra. No advance payments can be made, payment in full (after deductions for service level performance) will be made after successful declaration of result of the examination conducted.

Evaluation by QCBS method is under consideration. Following are the proposed qualification criteria.
